APPROVAL	Our acceptance of all customer orders is subject to approval, and is based in part on the customer's acceptance of the TERMS & CONDITIONS listed below:
SHIPPING TERMS	F.O.B. Mount Airy, NC
BILLING TERMS	Payment due immediately upon pickup/delivery.
PAST DUE ACCOUNTS	Invoices not paid within the specified billing terms will be subject to a service charge of 1.5% per month. This service charge shall be levied each month until all overdue balances are paid. Buyer hereby agrees to pay WHOLESAL MONUMENT COMPANY, INC. all such service charges regardless of any purchase order stipulations, or company policies that buyer may have to the contrary. Amounts due withheld as a result of disputes will not be subject to service charges if the disputed amounts are resolved in favor of the buyer. However, disputed amounts resolved in WHOLESAL MONUMENT COMPANY, INC.'s favor will be levied service charges.
COST OF COLLECTION	If buyer fails to pay any amount when due, including service charges, buyer agrees to pay the full amount of any costs or expenses, including reasonable attorney's fees, incurred by WHOLESAL MONUMENT COMPANY, INC. in the collection of such overdue amounts by litigation or otherwise.
NSF CHECKS/ CREDIT CARD PAYMENT FEES	There will be a \$45.00 service charge for all returned checks. Payments made by credit/debit cards will incur a 3% convenience fee.
